Currently, we are the biggest non-state provider of social and health services in the Czech Republic and the second largest Czech organization focused on humanitarian aid and development cooperation abroad. We provide social and healthcare services to people in distress or acute need. We make life easier for the disabled, terminally ill, homeless, victims of domestic violence and foreigners living in our country. We help in emergencies such as floods, fires and natural disasters. FROM THE CODE OF CONDUCT OF CARITAS CZECH REPUBLIC

Caritas fulfils its mission
primarily through material, social,
humanitarian, development,
psychological and spiritual aid to
people in need, as well as through
its efforts to promote more fair and
just conditions in our society.
Caritas influences and co-authors
social policy, draws public attention
to the existing forms and extent of
distress, and promotes
attitudes of solidarity.

The ultimate goal of our charitable services is to protect human beings and their dignity from conception to natural death. Caritas's staff are committed to providing effective assistance while encouraging independence and self-help skills whenever people find themselves in various situations of threat or emergency.

The charity service is based on respecting, protecting and developing the natural rights of every human being (as described in documents important for work of a charity worker, especially the **Universal Declaration of Human** Rights, the United Nations Charter of Human Rights and the Convention on the Rights of the Child and other international declarations and conventions: it is also governed by the Constitution of the Czech Republic, the Charter of Fundamental Rights and Freedoms and other laws of Czech Republic that derive from these documents). It is also based on the Christian concept of ethical values. anchored in the Bible and in the social teaching documents of the Catholic Church. It is also governed by the Statutes and internal rules of Caritas Internationalis, its standards and quidelines.

The charity service is provided to people at risk or in need, regardless of their age, gender, political opinion, family structure, health, sexual orientation, social and economic situation and status, ethnic or national minority, faith, religion and culture. The charity service abroad is carried out with respect for local cultures and religious beliefs.

AT CARITAS CZECH REPUBLIC **IN 2023**

- At the beginning of January, the Three Kings went house to house to wish a happy New Year, to pass on the blessings and to give people an opportunity to help those in need through the 23rd edition of the Three Kings Collection (see more on page 16) in various locations of the Czech Republic.
- At the conference in January, Caritas Czech Republic presented the results of the internal survey focused on the impact of the current energy crisis and inflation on social services and their clients to journalists.
- Caritas Czech Republic has released CZK 300,000 from its crisis fund and immediately set up the Caritas collection for Turkey and Syria (see more on page 33) to aid these two countries stricken by the catastrophic earthquake, measuring 7.8 on the Richter scale, early in the morning on February 6th.
- At the press conference called **One Year with** Ukraine (Rok s Ukrajinou), its director Lukáš Curylo presented Czech statistics, an overall overview, as well as very specific stories and aid that Caritas has provided to people affected by the war. The unfortunate one-year anniversary was commemorated with a photo exhibition One Year with Ukraine through the camera of the German Photographer Philipp Spalek

at Václav Havel's Square in Prague and other events throughout the Czech Republic. On the Sixth Sunday of Easter, the traditional

collection to help persecuted Christians and others in need took place in churches helping thousands of people in need every year.



- As a long-term partner of food banks, we joined the spring and autumn rounds of the **Food Collection** throughout the country this year too.
- In cooperation with the music foundation Stadler-Trier and the endowment fund Hudba pro Věčnou naději, Caritas Czech Republic has launched a series of classical music concerts for the elderly called Radost hudbou (Joy from Music).
- In mid-April, the Chamber of Deputies of the Czech Republic approved an **amendment to the** Asylum Act that grants the children of third-country nationals who have a long-term residence permit in the Czech Republic the right to

participate in the public health insurance system. The long-awaited change was pushed through thanks to the tireless efforts of Caritas Czech Republic and other organizations working with

- The Young Caritas Forum focused on getting young people involved in Caritas' activities took place in Kampus Hybernská.
- We supported people affected by the devastating explosion at the Kakhovka dam in Kherson Oblast, Ukraine, and the subsequent flooding that hit towns and villages on the banks of the Dnieper River, exacerbating an already catastrophic humanitarian crisis in Ukraine (see more on the page 30).
- Caritas Czech Republic has released funds from its crisis fund, established to help in emergencies and unexpected disasters, and at the same time it launched a collection to help Slovenia affected by
- Caritas Czech Republic has announced a collection to help people affected by the catastrophic earthquake in Marocco, which destroyed six densely populated provinces on the night of Friday 8 to Saturday 9 September.
- We celebrated the second year of our podcast with a new format - the ChariTALK special, which featured a moderated discussion of experts from non-profit and governmental sectors on the topic of improving the quality of social and health care in our country.
- We commemorated the **10th anniversary of our** branch in Zambia, which has grown to become our

largest branch abroad and where we have succeeded in improving health care for mothers and children, supporting refugees in education and helping farmers adapt to the climate change (see page 42 for more information).

■ In the parterre of the National Technical

- Library in Prague, we exhibited a set of 16 photographs called Mladí talentovaní Ukrajinci (Young talented Ukrainians) in cooperation with Caritas Uherské Hradiště. The students of the Photography and New Media Department at the ZUŠ Uherské Hradiště narrated the stories of these young Ukrainians who were forced by the war to flee their country through their portraits.
- The war between Israel and Hamas has caused a humanitarian catastrophe. That is why



Caritas Czech Republic has released funds from its crisis fund and launched a collection to help affected civilians in the Gaza Strip.

■ Representatives of Caritas Czech Republic



November 2023, Caritas ČR received a symbolic cheque for CZK 4,623,510 from E.ON to support Caritas' clients from the Energie pomáhají project. The first round of aid took place from May to July when E.ON distributed money for registration. Caritas Czech Republic received CZK 500,000 in the first round, and we divided this amount among eight regional branches where diocesan Caritas provide specialized counselling and services for people in need.

received the **Medal of Merit for Diplomacy**, which is awarded to people and organizations that have made a significant contribution to the development of foreign relations between the Czech Republic and other countries, from Czech Foreign Minister Jan Lipavský.

■ The Vinohradská 12 gallery hosted the exhibition My tři králové jdeme k vám... (We, the Three Kings, are arriving...), which was inaugurated by the author of the photographs Josef Vrážel and the Archbishop of Prague Mons. Jan Graubner. The collection of black-and-white pictures was shot in collaboration with Caritas Nový Hrozenkov during the Thee Kings' carol in the region of Valašsko during a period of almost ten years.

Providing food and material aid to people and families in need continued, funded by the Fund for European Aid to the Most Deprived (FEAD) and by the national budget via the Operational Programme of Food and Material Assistance (PoMPo II). In total, almost 40 thousand people were supported with food and almost 32 thousand people received material aid in 2023.

POMPO III

The aim of the project is to provide food and material aid for people from target groups (people in serious food or material need, e.g. homeless people, families in shelters, seniors, single parents, children and others), which is distributed in cooperation with the Ministry of Labour and Social Affairs through partner organizations, including the Caritas Czech Republic and its participating entities - individual diocesan Caritas. In addition to selected food items, other essentials such as basic household supplies, hygiene items, school supplies, tents and sleeping bags, and textiles are provided. Along with the distribution of aid, accompanying measures are provided to the assisted people, contributing to the solution of their difficult situation.



MILITARY SOLIDARITY FUND

The Military Solidarity Fund was created as a **joint project between the Ministry of Defence of the Czech Republic** and Caritas Czech Republic in 2015. In November 2023, both organizations signed a new Agreement on Mutual Collaboration, which significantly widens the group of potential applicants for support who find themselves in a difficult life situation. Now, the support can be provided also to professional soldiers within five years of leaving active military service, and most importantly, also war veterans and their loved ones and bereaved persons. All soldiers serving in the Czech Army, Military Police, Military Intelligence, Castle Guard and Military Office of the President of the Republic can apply for financial support.

Caritas Czech Republic manages a large database of donors (companies as well as individual donors) who contribute to the fund and works closely with the fund's board on processing donation agreements and providing financial assistance. In 2023 we administered financial gifts in the total amount of

CZK 9,390,700 for the Military Solidarity Fund. We distrib- uted CZK 3,220,000 using the form of donation agreements. The Military Solidarity Fund publishes its own annual report which can be found at https://fondsolidarity.army.cz.

CARITAS CZECH REPUBLIC AWARD 2023

On Friday, 20 October, the sixteenth award ceremony of the Caritas Czech Republic Award took place, for the third time in a row in the Cathedral of Saints Vitus, Wenceslaus and Adalbert at the Prague Castle. It was traditionally preceded by a Holy Mass in honour of St. Vincent de Paul and charity work. The Caritas Award has been given annually since 2008 to outstanding staff, volunteers or supporters for their dedicated work.

SIGNIFICANT EVENTS AND PROJECTS



IN THE ARCHDIOCESES AND DIOCESES IN 2023

DIOCESAN CARITAS BRNO

■ The Brno Caritas included live camels again in the Three Kings Procession organized within the Three Kings Collection after the two-year Covid pause. ■ All the Caritas branches of the Brno diocese continued helping people fleeing from the war in Ukraine. They provided social and legal counselling, assistance at institutions, translations and interpreting or assistance with looking for work and housing. Thanks to the collaboration with a Ukrainian psychologist Caritas Brno was also able to provide psychological help to 35 newcomers in their native language. ■ The regional Caritas Znojmo continues to cooperate intensively with partner Caritas located directly in Ukraine and supplies them with material aid (other Caritas branches of the Brno Diocese also participate in providing this aid). ■ The volunteer centre in Brno launched a new programme supporting volunteers and clients - cycle therapy. The unique cycle rickshaw can provide clients with physical limitations with the joy of movement in the fresh air. ■ In October, the traditional collection Koláč pro hospic proved that

the popularity of hospice and palliative care among donors has been growing. The proceeds from the collection amount to CZK 2.5 million and the money will help patients of mobile hospices in the entire diocese as well as patients of the inpatient hospice in Rajhrad. On this occasion, the follow-up service of the counselling centre for the bereaved called Křídla vážky, operating under the regional Caritas Blansko, was presented to the public.

DIOCESAN CARITAS ČESKÉ BUDĚJOVICE

■ The Diocesan Caritas České Budějovice opened the Agáta centre for victims of domestic and gender-based violence in Dobrá Voda u Českých Budějovic. At the same time, it initiated the establishment of a professional platform Spolu proti násilí (Together Against Violence) in South Bohemia. The Diocesan Caritas České Budějovice sent its first volunteer abroad within the European Solidarity Corps. ■ Caritas Český Krumlov fused with Caritas Kaplice. ■ Caritas Týn nad Vltavou has a newly registered social activation service for families with children. ■ Caritas Horažďovice opened a civic counselling centre in Nepomuk. Caritas Písek moved to a new address (Soukenická 161, Písek) and extended its car fleet of the field care service. They also launched a new project of the integration service of the Aid Centre to Help Refugees from Ukraine in Pisek and

Milevsko. CaritasTábor increased the capacity of the hostel Tábor with 4 beds for women. Caritas Pelhřimov fused with Caritas Pacov at the beginning of the year and took over its services. Since the beginning of May 2023 there has been the Caritas safety net working in Pacov - Community aid centre. Caritas Prachatice-Vimperk was created by joining Caritas Prachatice and Vimperk together. The social activation services for families with children were expanded. The reconstruction of the Home of St. Peter for men in Záblatí was started with the aim to increase its capacity.

DIOCESAN CATHOLIC CARITAS HRADEC KRÁLOVÉ

■ Parish Caritas Litomyšl took over the operation of the Mendryka Caritas Home from the Czech Catholic Caritas. Its mission is to provide home to infirm people who devoted their lives to the service of the Church. ■ Regional Caritas Polička launched a new service for the public which is called "a bridge" and provides support after losing a loved one as well as crisis intervention.

There are new after-school clubs for children as well: the Igráček club and the integration club Dráčci for preschool children. These activities are possible thanks to our partnership with UNICEF. ■ The Volunteer Centre of the Diocesan Caritas Hradec Králové also works as the Regional Centre for the region of Hradec Králové. In addition to our activities, we try to support non-profit

organizations that work with volunteers in other regions as well. The award "Osobnost v sociálních službách" (Personality in Social Services) was granted to Petr Macl from the Regional Caritas Hradec Králové. Anna Brázdová, the head of the Volunteer Centre of the Diocesan Caritas Hradec Králové, received a special award from the committee. The award of the Association of Social Service Providers and Diakonia of the Evangelical Church of Czech Brethren "The Caregiver of the Year" was given to Drahuše



Řezníčková from the Caritas Care Service Červený Kostelec. ■ The young volunteer from the Diocesan Caritas Hradec Králové Natalia Haddad from Syria received a diploma from the Office of the United Nations High Commissioner for Refugees in Prague for her extraordinary contribution to the wider community.

DIOCESAN CARITAS LITOMĚŘICE

■ Diocesan Caritas Litoměřice opened the

Integration and Community Centre Svit. A project was launched to increase the professionalism of staff in the areas of strategy, fundraising, financing and training. ■ The transformation of care services towards the modernisation corresponding to the quality of the services in the 21st century has begun. ■ Caritas Litoměřice completed the electrification of its car fleet. Diocesan Caritas Litoměřice became a recognized leader in setting the new trends in care services and the second largest care services provider in the region. Caritas Most received a donation from the President of the Czech Republic Petr Pavel, which was used to provide for the needs of children in the Centre for Children in Need of an Immediate Assistance. ■ Mgr. Světlana Nikolova was appointed the director of Caritas Most. ■ Bc. Kamila Svobodová, Dis was appointed the director in Šluknov. ■ In Česká Kamenice, the staff joined Běh pro Žlutou stužku - a running event to support people with criminal records. ■ In Česká Lípa, a project of a comprehensive reconstruction of a building in which services for children and families are provided was supported. ■ In Ústí nad Labem, they moved the services offered in the Home of St. Maternus to Mojžíř. ■ The Honorary Badge from the Ukrainian people for humanitarian merit was awarded to two workers of Caritas Rumburk: Martina Škodová and Veronika Jungová.



ARCHDIOCESAN CARITAS OLOMOUC

■ Caritas Uherské Hradiště cooperated with ZUŠ Uherské Hradiště to organize an exhibition of photographs taken by talented Ukrainian children who had to flee from the war and continue to develop their art in the Czech Republic. The exhibition was presented throughout the Czech Republic during the year 2023. ■ Caritas Strážnice was the first Caritas in the Czech Republic to obtain the certification for the ethics education programme DEKACERT®. ■ The Caritas counselling centre NEDLUŽÍM ("I have no debt") celebrated its 10th anniversary. It is run by Caritas Šternberk and it works in Šternberk, Uničov, Litovel, Moravský Beroun and Skrbeň. ■ Archdiocesan Caritas Olomouc provided basic material aid and food to people affected by the floods in June in Haiti.

■ The 25th edition of the Romani Pilgrimage took place at Svatý Kopeček u Olomouce with the theme "Mary, Mother of Us All".

The first year of the charity event called "Moving for Home Hospice Antoninek" took place in Nivnice. The run was attended by 323 participants and raised CZK 112,030. The Home Hospice Antoninek is a joint project of Caritas Uherské Hradiště and Caritas Uherský Brod. ■ Archdiocesan Caritas Olomouc delivered 642 generators, 1,501 mobile gas stoves, including the same number of refillable PB cylinders, 12 large-capacity heated tents and other material aid to Ukraine with the one-year duration of the project Světlo a teplo pro Ukrajinu (Light and Warmth for Ukraine). Moreover, in cooperation with the Olomouc regional authority it helped to finance the construction of several boreholes for drinking water.

DIOCESAN CARITAS OSTRAVSKO-OPAVSKÁ

■ In August 2023, the two-year project Romští lídři – hybatelé změny (Romani Leaders - Agents of Change), which connected Romani leaders from Ostrava, Přerov and Třinec and provided them with education, was completed. During the course of the project the regional Romani platform Feder Drom was created. ■ The Caritas home of peaceful old age of St. Francis run by Caritas Bohumín marked its 25th anniversary. ■ Caritas Český Těšín celebrated its 30th anniversary and opened its second

low-threshold facility for children and youth called Maják. ■ Caritas Frýdek-Místek organized the second edition of the event Duše na dlani focused on mental health awareness. ■ Caritas Hlučín got a donation from the President of the Czech Republic Petr Pavel amounting to CZK 335,500 to purchase a car for providing home health care.
Caritas Jeseník opened a new building of the Day Care Centre Simon in Jeseník for people with mental and combined disabilities and a new service of the Assistance Centre of St. Martin. ■ Caritas Opava organized a professional conference called "Závislost je také nemoc" (Addiction is a disease too). ■ Caritas Ostrava expanded its counselling services to include a specialised counselling service for victims of sexual violence not only in the church environment.

DIOCESAN CARITAS PLZEŇ

■ Diocesan Caritas Plzeň celebrated 30 years since its foundation at the mass in the Cathedral of St. Bartholomew. The celebrations also included the traditional benefit ball organised by the Centre for Development Cooperation, which commemorated 20 years of aid in South America. ■ A multi-purpose


facility for people in need was built at the Diocesan Caritas Centre in


Cukrovarská Street in Plzeň with funding from the City of Plzeň and the European Union. Food aid is distributed here, and the facility is also equipped with

a shower, toilet and basic clothing. The facility is open to other helping organisations as well. ■ Three exhibitions of paintings made by seniors from the Home of St. Elizabeth were on display in Pilsen exhibition facilities during 2023. The artworks were created during the occupational therapy workshops led by Eva Vyškovská. ■ The Municipal Cartias Plzeň opened a new building of the St. Francis for people without shelter in Wenzigova Street in Pilsen, which resulted in a significant increase of the capacity of the shelter, hostel and low-threshold day centre. ■ The Home for the elderly of St. George, run by the Municipal Caritas Plzeň, celebrated 20 years since its foundation. The Home of St. Aloysius of the Municipal Caritas Plzeň was once again awarded the quality certificate Vážka with an excellent rating based on an audit conducted by the Czech Alzheimer's Society after two years and focused on assessing the quality of care for seniors with dementia.

ARCHDIOCESAN CARITAS PRAGUE

■ The Caritas of the Archdiocese of Prague celebrated two important anniversaries in 2023: 30 years of its renewed activities after the fall of communist regime and the 1050th anniversary of the foundation of the Prague bishopric. ■ The comprehensive reconstruction of its headquarters in the Vinohrady





the field of foreign development and cooperation, Caritas Prague run programmes mainly in India, Uganda and Belarus. The programme Adopce na dálku®, which is the longest running Czech development project abroad, marked its 30th anniversary. Since 1993, Czech donors have supported the education of more than 36,000 of the poorest children. ■ In February 2023, Army General Emil Boček gave the Caritas of the Archdiocese of Prague the "Moral Authority" award for its perseverance, bravery and courage.

GREEK CATHOLIC CARITAS

■ We provided assistance (spiritual help and support, counselling, organizing leisure activities for children, etc.) both to newly arrived Ukrainians with temporary protection and directly to people in Ukraine in 2023 too. It mainly consisted in coordinating assistance provided to combat units at the front (raising funds for purchasing cars, ambulances, drones, night vision devices, clothing, hygiene supplies, medicines and food supplements, etc.). ■ We spent time with Ukrainian children, we tried to provide a space for families to meet regularly and to enable children to communicate with their peers in their native language. ■ We co-organized a summer camp for children and their parents, which was attended by dozens of people, once again in the summer. • We cooperate with other organizations, such as "Dětem Ukrajiny" - we provided them with funds to provide schooling for children who had not been admitted into Czech schools. ■ Financially, we help people who have found themselves in a difficult life situation.

VOLUNTEERS



A tremendous form of support for what we do comprises tens of thousands of volunteers who are willing to selflessly provide assistance and donate some of their time, energy and abilities for the benefit of others. They play an indispensable role in common everyday situations as well as in unexpected, challenging situations and crises. Without them, it would be nearly impossible for Caritas Czech Republic to carry out its activities and provide its services.



In 2023, 83,795 volunteers supported the activities of the nationwide Caritas network. They selflessly worked for 292,779 hours, i.e. 12,199 days or 33 years.

In 2023, 62,102 small and large collectors and organizers volunteered during the Three Kings **Collection**, thus donating **257,627 hours** of their time, i.e. 10,734 days or 29 years.

Volunteer activities include:

- Visiting clients in their homes
- Accompanying clients (e.g. to meetings at government offices, visits, excursions)
- Activities with mentally disabled clients (painting, musical activities, handicrafts, etc.)
- Canine therapy and hippotherapy with clients
- Tutoring children and spending time with children
- Providing assistance to children in after-school clubs

- Assistance with organising and managing children's camps
- Administration of Caritas' facilities
- Administration of Caritas' professional agenda (legal, editorial, IT)
- Maintenance and gardening work
- Assistance with food distribution
- Assistance with organising cultural and sporting events
- Organisation of food and clothing drives
- Help with transporting clients to Sunday religious services
- Tutoring foreigners and assistance with translating and interpreting
- Correspondence with prisoners
- Production of gifts for lonely seniors
- Assistance in home hospice care

On average, one arch/diocesan Caritas provides 10 of these volunteer activities. The most frequently performed activities include tutoring children and spending time with them, helping to organize cultural and sporting events, accompanying clients (to meetings at offices, visits, trips, etc.), helping to prepare and run camps for children, and organizing food and clothing collections.

A total of **2,187 volunteers** took part in these and other activities on a long-term basis and 7,229 volunteers on a short-term or one-off basis. They dedicated a total of **146.954** hours of their time to people who needed their help.







THREE KINGS COLLECTION

The traditional Three Kings Collection, in which carollers dressed as the Three Kings go to the streets of towns and villages to spread the message of peace, love and hope, is inherently one of the most important charity events of the beginning of a new year. In 2023, the Three Kings Collection reached a record proceeds of CZK 165,686,000 - this is a result of selfless enthusiasm of more than 75,000 volunteers and the unceasing generosity of our donors.

Over 155 million CZK (i.e. 25 million more than in the previous year) were collected on the streets. Online collection contributed with more than 3 million CZK to the collection and cashless donations reached 5 million CZK. The annual Three Kings Concert, which is broadcast on the Czech Television every year, and which hosted artists such as Kateřina Marie Tichá, Adam Mišík or the band Like-it, contributed CZK 1,526,790 to the account of the collection.

The proceeds are used in the entire network to fund a rich variety of Caritas' services and activities that have a direct influence on lives of people in need. For example, Caritas Kyjov and Caritas Přerov



invested the collected funds in supporting socially vulnerable groups and health care. In Blovice in the Pilsen region, they plan to help people in need, especially numerous families with several children and seniors. In Česká Kamenice, they will support home hospice health care and assist in purchasing school supplies and paying for multi-day school trips for children from socially disadvantaged backgrounds. Caritas Semily is preparing a food donation for families and seniors, and they also want to pay for school lunches for children from socially disadvantaged families. Caritas Jeseník will support the Daily Short-Stay Service Centre Šimon for people with reduced self-sufficiency. Caritas Odry will use the proceeds to

work with homeless people, to expand the offer of its rental of compensatory aids and to renew its car fleet.

This diversity proves that money from the Three Kings Collection is crucial for many projects helping people throughout the Czech Republic.

SOCIAL AND HEALTHCARE SERVICES

We focus on helping people who have found themselves in a difficult life situation. Our main activity is providing social and healthcare services, including specialized counselling. We help poor families with children, single parents, seniors, homeless people, victims of domestic violence, and sick and dying people. We also help people who are mired in debt and show them the way out of the debt trap and the grey economy. Finally, we also focus on providing assistance to everyone who has been affected by an extraordinary event, whether that involves an energy crisis, natural disasters or war in their homeland. We help without making any distinctions. No one is indifferent to us, and we are not indifferent to what is happening in the Czech Republic and in the European Union.



We help people directly by finding appropriate ways to resolve their specific difficult life situations. At the same time, we focus on advocacy activities to achieve long-term improvement for the broadest spectrum of disadvantaged groups of people living in the Czech Republic. Our main tool for making the necessary changes is pressing for changes in social legislation as well as participating in drafting social and health-care policies. The representatives of Caritas Czech Republic serve in many working groups and committees (at ministries as well as in the government). We collaborate with a number of other institutions both in the Czech Republic and throughout Europe on defending legitimate interests of people and achieving better living conditions. We have long been



cooperating with the European Anti-Poverty Network (EAPN Czech Republic and EAPN EU), Platforma 10, the initiative Za bydlení, the platforms Platforma pro sociální bydlení, Oddlužme Česko, and the Union of Employers' Associations.

We systematically **fight against poverty and inequality in society** to benefit disadvantaged groups of people, including women, Roma and people who are vulnerable to poverty. Women in Czech society are four times more vulnerable to poverty than men. Better financing of social services and fair remuneration for social workers and home-care nurses, financing for foster care, recognition of informal caregivers and support for single parents – all these are areas in which

women predominate, where their work is underpaid and where Caritas Czech Republic is striving to implement necessary changes with the aim of **helping** to ensure equal conditions and decent income for

We have started to address the growing poverty in cooperation with E.ON as a part of the **programme called Energie pomáhají**. In 2023, our assistance services focused mainly on seniors, people with heath disabilities, poor families, single parents and poor individuals. It became clear that due to increased energy, food and housing costs, the social benefit system was failing, and without compensation from our project, poverty of many people would be exacerbated. The project is still ongoing.

WE PROTECT THE INTEREST OF THE DISADVANTAGED AND VULNERABLE

In cooperation with our umbrella organisation, Caritas Europa, we also address **Romani issues** during our advocacy work. We share our experience on how we support Roma communities in our respective countries within the working group. Through our advocacy work

and mutual sharing, we work to strengthen human dignity of Roma population in Europe despite persistent structural inequalities and generational poverty. In 2023, we went on a study visit to Slovakia, hosted by Caritas Slovakia in Bratislava and its dioceses in Poprad and Košice.

For Caritas' work, it is necessary to **share good practices and experience.** For this purpose, we use meetings of the committees at the diocesan levels and at the national level. These committees provide an expert platform for our workers from the same fields to consult and propose new actions.

In the social and healthcare area, **nine specialised committees** work at the national level:

- Committee on shelters for mothers with children in need
- Migration committee
- Committee on counselling centres
- Committee on social activation services for families with children
- Committee on social workers methodologists
- Committee on social projects
- Committee on social services for homeless people
- Committee on social services for seniors
- Healthcare committee

CARITAS' SERVICES

In 2023, we provided 1,231 services within the nationwide Caritas network. Social services are registered pursuant to the Act No. 108/2006 Coll., on Social Services, which classifies them into three groups:

- specialized social counselling
- social care services
- social prevention services

In the overall list, we also include:

- healthcare services
- other services (i.e. supplementary and supporting services that cannot be included in the abovementioned categories)



SOCIAL AND HEALTHCARE SERVICES IN 2023

- SPECIALIZED SOCIAL COUNSELLING CENTRES

Counselling-centre employees assist clients in dealing with government offices, mediate necessary assistance for them, and focus on labour-law relations, housing, family, interpersonal and property-rights relations. They provide assistance for all people in need and strive to help them find a way out of their difficult life situations.

Caritas has 72 specialised counselling centres, which carried out a total of 205,621 contacts and interventions in 2023 helping 50,738 individuals.

Out of the total of 72 counselling centres, 61 provide basic civic counselling. Out of this number of counselling centres, 53 provide debt counselling and 41 are accredited to write and file insolvency petitions. In 2023, debt counselling centres provided help to eight thousand clients. The total number of debt counselling contacts and interventions was 54,155.

- SOCIAL CARE SERVICES

Caritas' services provide support and assistance to people who have diminished self-sufficiency due to health limitations or other disabilities and whose current situation requires an assistance of another individual, when family members and loved ones are unable to fully provide such assistance. In 2023, social care services, of which Caritas operated 362, were provided to 28,366 clients.

This primarily involved field care services and personal assistance, as well as emergency care and support for independent living. Relief services help people who have decided to take care of their loved ones themselves. Daily and weekly short-stay and day-care service centres are also available. If circumstances do

not allow users to remain in their home environment. a number of residential services is offered: homes for seniors, homes with a special regimen and sheltered housing services.

In terms of scope, the most significant are **field care services**, of which Caritas has **114**. These field services helped 18,160 clients; a total of 4,071,070 interven**tions** were carried out by caregivers.

These include **355 registered services** with a total of **57,568 users**. Social prevention services help to **prevent** the social exclusion of people who are at risk due to a crisis or socially disadvantageous environment, or because of their addictions, lifestyle, or many other factors. The aim of preventive social services is to help such people to overcome their unfavourable social situation and, at the same time, to prevent the occurrence and spread of undesirable social phenomena.

- SOCIAL PREVENTION

SERVICES

One such group comprises homeless people, who find immediate assistance, such as the possibility to bathe, eat and rest, at low-threshold day-care centres. In 2023, Caritas registered **193,218 visits** and conducted **346,401 interventions**. One-off assistance and places to sleep are provided by hostels, which strive to motivate clients to use related social and public services. At 20 shelters for men and women, Caritas offers assistance to clients so that they can cope with their generally difficult social situation and provides accommodation for the absolutely necessary period of time. A total of **1,255 persons** requested this assistance in 2023.

Shelters for mothers and, as the case may be, fathers in need provide refuge for parents with children who are in distress. In 2023, a total of 13,089 parents and **children** comprising **1,013 families** were afforded housing in these shelters. Field programmes are also important for the long-term fight against poverty and



social exclusion, with more than **88,000 contacts and interventions**.

Social activation services for families with children, seniors and persons with disabilities are offered in field. Low-threshold clubs for children and young people from disadvantaged background offer their space to children and youth: 8,670 children and adolescents attended them in 2023. Families with children whose development is at risk are supported by early care services.

- HEALTHCARE SERVICES

Caritas Czech Republic is the **biggest provider of healthcare services in the country,** with a total of **179 registered healthcare facilities** employing **1,664 nurses** throughout the Czech Republic in 2023. Care was provided to a total of **70,195 patients** in 2023.

HOME HEALTH CARE

Home health care is provided by 78 centres, at which 972 nurses worked in 2023, treating 60,559 patients.

Home hospice care is provided as an integral part of home healthcare, which includes accompanying dying patients. Forty-eight home healthcare centres have a dedicated team of nurses specialising in caring for such patients. In 2023, these nurses took care of 1,614 of those patients. The average treatment time of these patients was 16 days. Only 2% of the patients eventually had to be hospitalised due to serious complications.

MOBILE SPECIALISED PALLIATIVE CARE

There are **184** nurses working in **19** mobile specialised palliative care teams. Over the course of the year, they cared for **2,348** patients. The mobile specialised palliative care team includes **112** specialist physicians (working mostly part-time) and makes it possible even for patients in an unstable condition and with serious complications to reach the end of their lives at home. The teams carried out **49,787** visits to their patients.

As a result of a series of negotiations at the Ministry of Healthcare and with health insurance providers, funding for mobile specialised palliative care has been improved. In the previous year, health insurance

companies had covered less than half of this muchneeded care. In 2023, more than three-quarters of
this cost was covered, mainly because the new procedures of introductory and final palliative care, which
are valued higher than other visiting days, were
included in the List of Healthcare Procedures. Each
patient received treatment for **36,1 days** on average
in 2023. Yet, the treatment time paid by health
insurance providers is only 30 days. The extra treatment time (6 days on average) is not paid. This
occurred in **522 cases**. Caritas had to pay these costs
form other resources. We will focus on this when
negotiating with health insurance companies on
treatment in 2025.

INPATIENT HOSPICE

Caritas Czech Republic operates **four inpatient hospices** with total capacity of **140 beds.** Last year, **75 nurses** took care of **1,030 dying people** in these hospices. The inpatient hospices are closely connected with both outpatient care and mobile specialised palliative care. It is thus possible to find the optimum care for every patient based on their specific illness and social conditions.

OUTPATIENT AND OTHER HEALTHCARE SERVICES

Caritas Czech Republic also operates outpatient services and provides healthcare at a follow-up care facility and a weekly short-stay care centre, which are connected with the provision of palliative and hospice care. These facilities include 11 outpatient pain-treatment and outpatient palliative medicine clinics and 3 outpatient physiotherapy clinics. In Olomouc, there are 2 general practitioner's offices for people in need and an outpatient psychiatric clinic for people in need. A new addictology outpatient clinic was opened in Jihlava. Caritas also operates 1 follow-up care facility and 1 weekly short-stay care centre registered as a healthcare facility. The scope of activity of the Mental Health Centres (in Uherské Hradiště and Svitavy) was expanded. The outpatient healthcare services treated 2,487 patients and employed **58 nurses and physical therapists** in 2023.

HEALTHCARE IN RESIDENTIAL FACILITIES

Through its nurses, Caritas provides healthcare at all **45 seniors' homes** and **13 homes with a special regimen**. These homes have total **capacity of 1,970 beds**. and employ **375 nurses**.

A total of **2,213 clients** received care in these facilities in 2023. A total of **513 clients** died in these facilities last year. Out of these, 206 clients of the residential facilities were hospitalized before their death. This is an ongoing challenge to improve care for the dying so that clients can die at home - especially collaboration with mobile specialist palliative care would help.

QUALITAS OPTIMA

The professional association of non-medical health professionals of Caritas Czech Republic - Qualitas Optima 2020 - continues

to develop its activities towards provision of high-quality healthcare. In 2023, it organized 12 professional webinars, which were open not only to its own members, but also to members of collaborating organizations, especially medical staff from Diakonie. In January 2023, Caritas Czech Republic with other professional associations of nurses organized a home health care conference at the regional office of the Central Bohemian Region under the auspices of the Deputy Governor for Health, Ing. Pavel Pavlík. Caritas co-organized with

the Centre for Social and Health Services Poděbrady o. p. s. a **conference on palliative care** in Poděbrady in May.

The professional association has also developed its mobile app for standard nursing procedures. This year, it has upgraded it to include a management application as well as procedure audit questions - these must be taken with no errors not only by entry-level healthcare professionals, but also all healthcare workers. For the first time, the mobile app also collects statistical data. The form of statistical collection through the mobile app makes the collection easier and more accurate compared to the previous years when the data were filled in Excel spreadsheets. All this enables Caritas Czech Republic to guarantee the highest quality of health care and reduces the time spent on administration, which can then be devoted to patients.

We are very grateful to our nurses, physiotherapists and doctors for their excellent professional work and empathetic and kind approach.
Thanks to them, our motto was still valid in 2023: CARITAS – THE BRAND OF THE HIGHEST QUALITY.

We are striving to address the issue of unaffordable housing by running social apartments, which we provide for affordable rental rates to poor people who do not have a possibility to obtain housing under the current conditions. In 2023, a total of **458 people, including 244 children**, lived in **141 social apartments**, 83 of which are part of Caritas' property and 58 of which are leased from other entities. A total of **444 clients**, including **112 children**, found shelter in **15 lodging houses**.

SOCIAL ENTERPRISES

Caritas also operates **20 social enterprises**. The social enterprises in the Caritas' network operate in, for example, the following fields of business: sewing workshops and laundries, bakeries and pastry shops, production of spa waffles, cafés, furniture renovation and manufacturing, food preparation and delivery, production and sales (e.g. medical aids, syrups, textile products), second-hand shops, graphics work, cleaning and waste disposal, among other fields.

The social economy and social enterprises are areas on which Caritas focuses also in the realm of advocacy. We consider social entrepreneurship to be a form of business with high value added for society. Social enterprises often employ people who would not otherwise find work due to their disabilities.



In 2023, the Marianeum Hotel and Training Centre continued with its mission to provide a high-quality accommodation and training centre in the centre of Prague. The hotel is owned by Caritas Czech Republic and its operation raises funds to support a variety of social, health and humanitarian projects home and abroad.

The hotel's services include pleasant and modern accommodation in single- to four-bed rooms and one wheelchair-accessible apartment (total accommodation capacity is 46 persons in 28 rooms) near the historic city centre, a top-rate concierge service, delicious buffet breakfast and, when the weather is nice, garden seating in the courtyard.

For business meetings, trainings, workshops, seminars, conferences, lectures, round tables, and other events, it is possible to rent **two meeting rooms** (auditoriums) and three classrooms with the option of renting audio and video equipment and ordering catering. The capacity of the meeting rooms ranges from 10 to 70 persons and a high-speed internet connection is available via Wi-Fi and there is also a fixed-line connection, which works flawlessly throughout the building.

2023 was a year of development and innovations. As for technical improvements, we started the process of replacing the windows and preparing for the installation of modern kitchen equipment (we continued with our previous collaboration with Biofood and Dr. Oetker and we were given a pastry oven and a pizza oven for free).

In addition to technical improvements, we also focused on service and customer relations. We launched a new **online booking system** which enables our guests to comfortably book a room directly on our website. This makes us less dependent on third-party selling platforms and decreases the

associated costs. As a result, the number of clients purchasing our services in the ALL IN ONE package (training, meals, and accommodation) has increased.

We are particularly proud of our cooperation with the project "Spolu dětem" (Together for Children), which focuses on helping young people from children's homes. We participate in the project by providing young people with learning opportunities and we help them to prepare for an independent life.

Staff changes in our team have brought a new energy and expertise which is evident in all aspects of our business. Our new Catering Assistant and Food Service Assistant have contributed to improving the quality of our services and customer satisfaction.

These improvements and innovations have enabled us to raise the standards of our accommodation and services, and they also strengthened our relationship with the community and supported sustainable growth compliant to the mindset of Caritas Czech Republic.




INTEGRATION OF FOREIGN NATIONALS

We help migrants and refugees living in the Czech Republic to become full members of our society with all the rights and responsibilities associated with that. The basis of our services consists in provision of free professional social and legal counselling, and other activities supporting integration. We collaborate with state institutions and contribute to the smooth coexistence of the majority society and newcomers. We strive to mitigate dis-





assistance with learning the Czech language and adaptation and integration activities as well as material aid. We were also supported in this by the **nationwide Emergency Appeal project** (see page 32) and other extraordinary projects, donations, and collections. There was a wide range of services available in newly opened community centres in Litoměřice, Plzeň and Prague. In Olomouc, refugees used the services of local counselling centre, and they participated in integration activities.

The counselling centres for foreign nationals and refugees (in Brno, České Budějovice, Hradec Králové, Plzeň and Prague) focus primarily on providing professional social and legal counselling. They provide clients with information, assistance with administrative matters and accompaniment to state and other institutions. The centres also provide interpreting for them when dealing with matters involving residence permits, employment, housing, and healthcare services. Within their projects, the

centres organise low-threshold Czech language courses, sociocultural orientation courses, integration Czech-language course and multicultural events, support the integration of resettled compatriots, and provide assistance to foreigners directly at certain facilities of the Department of Asylum and Migration Policy (OAMP) of the Ministry of the Interior. Caritas organisations also provide food and material aid to foreigners in need.

ADVOCACY ACTIVITIES

Representatives of Caritas are active in several working groups focused on migration, adaptation and integration, as well as in consulting on amendments to acts concerning foreign nationals and refugees. They collaborate with local authorities, the state administration, non-profit organisations, and other entities in the field of migration and strive to ensure peaceful coexistence and fair conditions for all.

HELPLINE IN THE MONGOLIAN, VIETNAMESE, AND UKRAINIAN LANGUAGES

For several years, the helpline has been helping Mongolians, Vietnamese and Ukrainians throughout the Czech Republic who find themselves in a difficult life situation. The helpline helps its clients to understand their rights and obligations, with understanding at healthcare facilities, at school and at state institutions, as well as with filling out forms

and translating official documents, while also offering contacts to other support services. It provides interpreting, information and psychosocial support via telephone and the internet and facilitates communication with foreigners for state offices and institutions.

In 2023, the intercultural operators of the helpline assisted a total of **5,023 clients** with integration into society.

The operation of the service in 2023 was supported by the integration programmes of the Ministry of the Interior with funding in the amount of CZK 2,506,255 and by the City of Prague with CZK 140,000. The expanded operation of the Ukrainian helpline was supported by the Prague City Council and City of Prague, the Network of European Foundations under the EPIM programme, the Faurecia Corporate Foundation and other sources.

AID PROVIDED BY CARITAS CZECH REPUBLIC TO UKRAINE

Caritas Czech Republic continued helping people affected by the war in Ukraine in 2023. Its activities ranged from direct support in Ukraine to helping refugees in the Czech Republic.

In response to the outbreak of war in 2022, Caritas Czech Republic announced a **public fund-raising campaign** to finance humanitarian aid for Ukraine, as well as to help manage the situation of Ukrainian refugees in the Czech Republic and Moldova.

Donors contributed CZK 10,536 million to the Caritas's collection account **Caritas for Ukraine** (account number 55660022/0800, VS 104) in 2023 (in 2022, it was CZK 163,151 million). **In total, the amount of CZK 173,687 million was collected in both years.**

HELPING DIRECTLY IN UKRAINE

The invasion of Russian troops forced millions of people to flee their homes. Almost 4 million people

remain displaced in their homeland. Our aims focus on providing **decent housing** to these people. In western Ukraine, we built modular houses and renovated housing areas, kitchens, bathrooms and laundry rooms of hostels. People who fled from the war to the west of Ukraine were directly involved in the renovation. This gave them a source of income in their new hometown.

Caritas Czech Republic helped people in the regions of Kherson and Mykolaiv to prepare for winter, mainly by insulating windows, providing fuel, winter clothes, shoes and warm bedding, in cooperation with our partner organization New Dawn.

We also distributed drinking water to people affected by flooding after the destruction of the Kakhovka dam and drilled 7 wells to provide **access to drinking water** for more than 10,000 people in southern Ukraine. In addition, we provided affected communities with water tanks, kits for repairing water systems and hygiene kits.

HELPING REFUGEES IN MOLDOVA

Since the beginning of Russian invasion of Ukraine, more than 800,000 people have fled to Moldova. For most, it was a transit country, but more than 100,000 refugees from Ukraine remain in Moldova.

For the poor country, the influx of refugees was a huge challenge. Caritas Czech Republic supported Moldova by supplying equipment for 12 refugee centres to help provide decent housing for refugees (supplying necessities such as beds, blankets, washing machines and fridges).

HELPING REFUGEES IN THE CZECH REPUBLIC

Extensive assistance was provided by individual local Caritas'in Brno, České Budějovice, Hradec Králové, Litoměřice, Olomouc, Pilsen, Prague and other places connected to the national Caritas network. It mainly includes counselling and assistance, i.e. the provision of information, introduction to rights and obligations (socio-cultural orientation), support in dealing with authorities and institutions (e.g. interpreting). We also provided material assistance, Czech language courses and psychological support to refugees in need.

We organized children's groups, summer camps and tutoring for children, which involved, among others,

employees and volunteers of the Global Education Department (GVO) of Caritas Czech Republic, which ran a leisure club for Ukrainian children in cooperation with the Municipality of Prague 1. These projects were also supported from the joint collection account, and the Emergency Appeal project also played a significant role in the funding.

EMERGENCY APPEAL 12/2022

Humanitarian aid and integration support provided to Ukrainian refugees in the Czech Republic

May 2022 - April 2023

The aim of the project was to provide material and integration assistance to war refugees from Ukraine in the Czech Republic. The assistance was aimed primarily at vulnerable people, such as children, parents with young and several children, single women, the elderly and people with health problems.

The project was financially supported by **donors from the network of Caritas Internationalis** (Catholic Bishops' Conference of Japan EUR 140,000, Caritas Spain EUR 150,000, Caritas Portugal EUR 5,000, Caritas Germany EUR 470,251, OBOS_Caritas Seoul EUR 93,500, Trócaire EUR 500,000, Canadian Catholic Organization for Development and Peace EUR 151,743) and Caritas Czech Republic co-financed it with EUR 102,765.

The total amount provided for the project was CZK 39,246,392 (EUR 1,613,259), supporting 40,309 people, more than half of whom were supported more than once. The entire network of Caritas Czech Republic participated in the aid.

EMERGENCY APPEAL 11/2023

Emergency response for people from Ukraine affected by the conflict

May 2023 - April 2024

The aim of the project was to provide material and integration assistance to war refugees from Ukraine in the Czech Republic. The assistance was aimed primarily at vulnerable people, such as children, parents with young and several children, single women, the elderly and people with health problems. In this follow-up project, our activities focused on mitigating the impact of reduced financial support from the state for the most vulnerable groups of refugees. We mainly focused on helping with integration into society, childcare, language learning and psychosocial support.

The project was financially supported by **donors from the network of Caritas Internationalis** (Catholic Bishops' Conference of Japan EUR 50,000, Caritas Portugal EUR 5,000, Caritas Germany EUR 200,000, Caritas Int. EUR 272,521, balance from EA12/2022 EUR 67,632).

The total amount provided to the project was **CZK 14,116,732 (EUR 595,153)** and 9,000 people were supported, with more than half of them supported more than once, by 31 January 2024. The aid was distributed throughout the Czech Republic thanks to the involvement of the network of Caritas Czech Republic.

AID PROVIDED BY CARITAS CZECH REPUBLIC TO TURKEY AND SYRIA AFTER THE EARTHQUAKE

The devastating earthquake that struck Turkey and Syria at the beginning of February 2023 killed nearly 60,000 people and left millions of people homeless. Caritas Czech Republic started to provide humanitarian aid to the affected people in Turkey and Syria immediately after the earthquake.

Together with our partner organisations, we distributed drinking water, warm meals, food parcels and basic kitchen utensils. We also provided hygiene supplies and psychological assistance to the local inhabitants. The catastrophic earthquake hit both states in winter, when the temperatures were low in the region. We have provided safe shelter, warm clothing, thermal blankets and fuel for the affected people to safely survive the winter.

In the Turkish province of Hatay, which was severely affected by the earthquake, we built **housing containers** with portable toilets and showers in cooperation with our partners. The housing containers provided affected people with a more

In Syria, the tremors hit areas in the Northwest of the country, which had already faced a major humanitarian crisis. Internally displaced people who have fled from other parts of the country to escape the war live here. The earthquake worsened their desperate situation. In addition to our immediate food and hygiene aid, we have distributed kitchen utensils kits to people in Syria so they can cook for themselves even if they live in

Long after the earthquake, local people are still coping with the trauma caused by the devastating earthquake. For this reason, we provided much needed psychological help and psychosocial support to help them cope with the trauma. In Syria, we have also organized **group therapy sessions** for children and youth and several **awareness-raising trainings** focused on earthquake preparedness and on tips for parents to help their children overcome the trauma caused by the earthquake.



HUMANITARIAN AID AND DEVELOPMENT COOPERATION



MIDDLE EAST

The Middle East region has been struggling with the consequences of ongoing or recently terminated armed conflicts. The consequences for locals have been dramatic - many have lost their homes, businesses or farms. At the same time, climate change has a significant impact on the region, particularly the severe drought, which has an impact on local farmers and their ability to earn a living. In addition, the region of Syria and Turkey was hit by a tragic earthquake last year, which worsened the already difficult situation of displaced Syrians. That is why Caritas Czech Republic focuses primarily on supporting livelihood through vocational courses and business skills trainings so that local people can set up their own businesses in the Middle East. Caritas Czech Republic has also helped farmers rebuild their farms destroyed by the self-proclaimed Islamic State. It also introduces modern farming methods to help farmers react to climate change. In Syria and Turkey, we were active in providing aid to people after the devastating earthquake.

A total number of 3,000 young people completed the courses, 300 of whom were already employed during the project and others found employment after the end of the project.

MAROCCO

Immediate humanitarian aid to earthquake victims in Morocco

September 2023 – October 2023 | CZK 130,000* (Collection for Morocco)

On the night of the 8th of September 2023, a strong earthquake measuring 6.8-6.9 on the Richter scale struck Morocco. Its epicentre was in the High Atlas Mountains. The devastating impact of the earthquake was particularly evident in five provinces: Taroudant, Ouarzazate, Azilal, and especially in the provinces of Al-Haouz and Chichaoua in the Marrakech-Safi region. Caritas Czech Republic was one of the first organisations at the site of the tragic event and together with Caritas Marrakech implemented a project aimed at providing immediate humanitarian aid to the victims. The main priority was to provide emergency housing for residents who had lost their homes. Tents were distributed in the first phase of the project, followed by blankets and clothing. The project also launched a food distribution programme for affected areas, with special attention to vulnerable groups (women, children, the elderly and people with disabilities). | SDG 1, 2, 3, 6

Morocco Earthquake Response

The epicentre of earthquake that hit on the 8th of September was deep in the Atlas Mountains.

Residents of the affected provinces are among the poorest inhabitants of the country by most socio-economic indicators. The approaching winter and the fact that most villages are in the mountains meant that providing emergency shelter would be a top priority. Caritas Czech Republic, together with Caritas Rabat, designed a project whose main element was to provide temporary shelter for residents. It has provided the essential material (wood, PVC, etc.) to improve insulation against temperature fluctuations, strong wind and humidity. The project has also involved distribution of clothing, mobile heating, temporary lighting or the provision of basic hygiene through the installation of showers and toilets. | SDG 1, 3, 6

GEORGIA

In Georgia, Caritas Czech Republic focuses, among other things, on the **development of health care and increasing the availability and quality of care,** especially in rural areas. We also **develop social services**, mainly the care for people with disabilities. As a part of ensuring adequate care, we have focused, for example, on building family-type homes, where people with disabilities are moved from large institutions to receive care according to their wishes and needs or ensuring accessible care through telehealth. In poor rural areas, we help people secure their livelihood, especially by supporting small businesses. We also focus on environmental protection and efficient waste management.



In 2023, as in previous years, we focused our **development** assistance in Mongolia on waste management and sustainable development, with a particular focus on plastics and construction waste recycling. At the same time, we continue to support civil society.

objective of the project was to support and empower youth civil society organizations and improve their ability to communicate with local authorities to gain a greater stake in development and decision-making in Mongolia, thereby strengthening good governance and democracy in Mongolia.

Sustainable plastics recycling in Mongolia

Switching on the green economy

January 2022 - December 2025 | CZK 7,999,100* (European Commission) | The main implementer of the project is People in Need.

The project builds on Mongolia's commitment to reduce greenhouse gas emissions by 22.7% till 2030. The project supports agricultural, food and beverage SMEs and retailers to adopt circular economy practices through a market-based eco-labelling system, capacity building, behaviour change and access to green funding. In 2023, the preparation and distribution of training manuals was completed, regular technical assistance meetings were held, and training of tutors took place. | SDG 1, 6, 8, 12, 13

UKRAINE

Ukraine has been resisting Russian aggression for three years. Millions of people had to leave their homes. Many have gone abroad, but nearly four million remain internally displaced. Caritas Czech Republic focuses on supporting these people to have their basic needs met, including decent accommodation. At the same time, we provide humanitarian aid to people in need; for example, we distributed equipment necessary to survive the winter or helped people affected by the flood after the destruction of the Kakhovka Dam.

Improve living conditions of IDPs in Zakarpatska Oblast and response to winterization needs of civilians in the frontline and de-occupied areas in Kherson and Mykolaiv Oblasts, Ukraine/ Emergency response to humanitarian needs related to Kakhovka Hydro Power Plant (HPP) explosion

February 2023 – December 2023 CZK 27,222,222* | (Ministry of Foreign Affairs of the Czech Republic, collections)

The aim of this project is to provide quality long-term housing for IDPs in the Zakarpattia Oblast and to mitigate the psychological impact of long-term displacement, as well as to provide basic in-kind humanitarian assistance to the civilian population living near the frontline and in

de-occupied areas. As part of the assistance following the Kakhovka hydroelectric power plant explosion, the project also ensured access to basic WASH services as well as the supply of personal hygiene and cleaning products for the implementation of basic infection prevention and control measures (IPC) among the population affected by the Kakhovka hydroelectric power plant explosion.



Provision of critical, life-saving winterisation support in Khersonska and Mykolaivska Oblasts of Ukraine

October 2023 – June 2024 | CZK 35,658,307* (Ukraine Humanitarian Fund)

The aim of the project is to address the urgent needs of IDPs, returnees and host communities in the Kherson and Mykolaiv regions linked to preparing for winter and providing shelter in

recently liberated and hard-to-reach locations. The project will support 9,853 direct beneficiaries through the installation of energy-efficient windows, fuel for heating and home insulation, as well as the distribution of winter household items and winter clothing kits. The project also considers gender perspective, violence committed on people and sexual exploitation and abuse issues using a comprehensive approach to prioritization in line with the recommendations of the Ukrainian government and the Shelter/NFI cluster and extensive training on violence committed on people and sexual exploitation and abuse issues provided to local partners.

ZAMBIA

Zambia is one of the countries with the highest levels of poverty and income inequality in the world. At the same time, the country is suffering from the effects of climate change, including prolonged droughts, which have a major impact on the availability of water and harvest, and therefore the ability of locals to secure their livelihood. In Zambia, we focus primarily on supporting refugees and developing economic self-sufficiency through sustainable agriculture and small business start-ups. We also provide college scholarships to vulnerable refugees and build farmers' resilience to climate change.



Enhancing Education (Lusaka) and Livelihoods of Refugees and their Host Communities in Zambia

January 2023 – December 2023 CZK 14,327,325* | (UNHCR - Office of the United Nations High Commissioner for Refugees, CRA)

Caritas Czech Republic contributed to the education of children and youth from socially vulnerable refugee families primarily in Lusaka, where it provided tutoring and other social and community



services for children and adults through lowthreshold centres. In Lusaka and in the refugee settlements of Mayukwayukwa and Maheba, we promoted access to livelihood through interventions focused on financial inclusion, business skills development, support to small farmers and cooperatives, improved agricultural productivity, support to small businesses and processors, as well as through collaboration with the private sector. A trilateral project with the budget of CZK 3,946,500 (CRA) complemented this intervention and it aimed at promoting sustainable and profitable agricultural production and the development of value chains. The project provided training and agricultural inputs to 300 farming families.

Increasing productivity and supporting the development of mango, cassava and organic fertilizer value chains in Western Province, Zambia

January 2023 – December 2023 | CZK 736,890* (CRA, Three Kings Collection)

The objective of the project was to increase agricultural productivity and add value to the production and processing of mangoes, cassava and organic fertilizer production in the Mongu district of the Western Province in Zambia. Most of the interventions were completed by the end of 2022, however, the one-year extension of the activities significantly strengthened the sustainability of the enterprises involved. Last year, we also trained employees of five companies in e-commerce and provided a follow-up support in online marketing. | SDG 1, 2

DAFI scholarship programme – tertiary education for refugees

January 2023 – December 2023 | CZK 4,816,024* (UNHCR)

The project conducted in cooperation with the German Embassy in Lusaka, which is in its fifth year, aims to improve access to tertiary education for talented young refugees in refugee camps and urban communities through the DAFI (Deutsche Akademische Flüchtlingsinitiative Albert Einstein) scholarship. In 2023, we supported 87 refugees in studying, providing them not only with funding for tuition fees but also with travel, book and housing allowances. The project also supported students through experienced consultants providing career and psychosocial counselling. | SDG 1,4

Increasing access to working capital and inputs through promotion of saving groups to farmers and traders

January 2023 – June 2023 | CZK 2,355,928* (Financial Sector Deepening Zambia)

This project follows the implementation of a project targeting four districts in the Luapula province implemented from January 2019 to December 2021. The second phase of the project, launched in 2022, aimed to improve the financial inclusion of rural communities in five districts of the province through capacity building and engagement with traditional leaders and village representatives. Furthermore, the promotion of financial education and the creation of savings groups through a model based on the so-called Master Trainers - trainers able to train and support the creation of new common savings associations. At the end of the 18-month project, 100 Master Trainers had been trained and 452 savings groups had been established with a total of 9,166 members in Lusaka and Luapula.

Developing an integrated approach to farming in the Western Province of Zambia, Phase III

January 2023 – December 2023 | CZK 50,000* (CRA)

The project aims to increase agricultural production and productivity of small farmers in the Western Province and to increase the resilience of the landscape to the impacts of climate change. The intention is also to increase the income of small farmers and thus contribute to raising the standard of living of the local population. Within this project, Caritas Czech Republic acts as a subcontractor for Mendel University in Brno, which leads the implementation. In 2023, we trained future tutors on financial literacy and innovation in business development. | SDG 1, 2, 15



Sustainable commercial tailoring production by Lusaka urban refugees

January 2023 – June 2023 | CZK 387,780* (Embassy of the United States of America Lusaka)

The project aims to establish sustainable and commercial tailoring production for refugee applicants and host communities in Lusaka by building and equipping a tailoring workshop, improving the capacity of tailors and linking them with markets. In 2023, we renovated and equipped tailoring workshops at the Makeni transit centre; production started in August. Within the framework of the project, we selected 20 people to use the workshop for their work, based on an evaluation of the motivation of interested applicants. In addition to the facilities, the tailors were provided with support when preparing a portfolio of suitable products and subsequent entry into the local market. Moreover, the tailors were trained in business skills and marketing, including digital marketing. | SDG 1, 2, 8

Green solutions for sustainable development and growth in Monze District

June 2023 – December 2023 | CZK 6,315,790* (CRA)

The project focuses on increasing agricultural production among small and medium farmers, especially women and young generation, in the Monze district of the Southern Province of Zambia. The emphasis is not only on improving the efficiency of individual farmers' production, but also on establishing business relationships with local



buyers and building value chains. During the project, farmers will gain technical knowledge in sustainable and environmentally friendly soybean and sunflower cultivation, post-harvest handling, processing and storage, production diversification, natural resource management, agroforestry and climate change. These farmers will have basic financial literacy skills and will use financial services. In 2023, the first year of the project, 1,750 small and medium farmers were selected for the project. As part of the project activities, experts for Mendel University trained 5 government officials and 10 private sector representatives as future trainers in organic and sustainable agricultural practices. At the same time, the first 43 savings groups were established.

A major challenge of 2023 was a long-term support of selected young people who improved something in their surroundings. Adaptation and integration activities for refugees from Ukraine culminated at the Young Caritas Centre. Young Caritas is also introducing the international concept of **Sustainable Development Goals (SDGs)** to the general public.

Young Caritas Advocates

This project works with young people aged 16 to 20 who want to become active citizens and change the world around them. We show them how to proceed and achieve solutions to specific issues in the places where they live. Internal and external experts provide them with education in the areas of communication, civil rights and the social pillar of a sustainable world. Thanks to the project, the participants understood the concept of sustainability and gained skills and experience that they can use as active citizens. The project included the Young Caritas Forum meeting for youth workers, which was hold in May 2023.

Within the programme, teachers and other professionals systematically enhanced their **knowledge** and skills in the social pillar of sustainable development. The Academy supported a school environment that motivates students towards social cohesion, encourages them to respect sociocultural diversity, develops their relationship with the surrounding environment, and thus deepened the pro-inclusiveness of the participating schools. An online living library with its dedicated website was created, a summer school for teachers was organized and a Young Caritas Methodological Guide was written within the project.

Young Caritas Centre

January/February 2023 – December 2023 CZK 1,499,625 (City of Prague, UNICEF) CZK 1,862,280 (the Ministry of the Interior of the Czech Republic) | CZK 171,075 (Caritas Czech Republic/humanitarian collection)

Since November 2022, the Young Caritas Centre on Haštalská street in Prague 1 has served primarily as

a place for adaptation and integration activities for **refugees from Ukraine.** This space was allocated and entrusted to our use free of charge by the Prague 1 Municipal District. However, Young Caritas became involved in helping people arriving from Ukraine thanks to volunteers and funds raised in a public collection soon after the war began. Within the Young Caritas Centre, there is a club room open every weekday for schoolchildren. There are also Czech language courses for children and adults. career counselling and occasional social gatherings such as St. Nicholas Day party and open breakfast organized in collaboration with the governmental campaign HateFree Culture. Refugees organized 15 **community events themselves there.** Together with Czech children, the refugees went on excursions to the surroundings of Prague and visited museums and galleries. As a matter of course, there is a professional team composed of pedagogical and social workers supplemented by volunteers. At the Young Caritas Centre, we helped more than 860 refugees from Ukraine in 2023.

2030 and the Czech Republic's foreign development cooperation with a deeper focus on sustainability, partnership and the involvement of young people. Within the Dialogue project, panel discussions and interviews with experts were organised and the International Volunteer Day was celebrated. The project has created a high-quality network of partners from the ranks of representatives of the civil, public and private sectors, including ambassadors of young people. Through cooperation, it actively contributed to the development of active citizenship among young people.

EVOCA (European Volunteers for Caritas)

January 2023 – December 2025 | CZK 78,799 (European Solidarity Corps)

Under the wing of the European Caritas, Young Caritas helps to recruit young people aged 18 to 35 from EU member states for long-term international volunteering in Iraq, Mongolia and Zambia. For a minimum of 10 months, trained and carefully selected volunteers assist humanitarian networks in areas such as public relations, project or financial management. In this way, they make a meaningful impact directly in the field and in return gain the desired experience and valuable references for their professional CV.

Storytelling for Europe

March 2022 – August 2024 | CZK 292,470 | (Erasmus+)

Caritas Czech Republic became a partner of the Storytelling for Europe project, which is managed

by the Slovak educational company Eduma, n.o. In addition to Caritas Czech Republic, the other partner organisations are Eurospeak Limited of Ireland and Marta Mas Languages of Spain, specifically Catalonia. The project has the aim of promoting and expanding the use of storytelling as an innovative tool for developing young people's competencies in informal and formal education. This involves development in the areas of language, critical thinking, empathy, setting values, advocacy and social responsibility, i.e. linguistic, digital, social and civic competencies. Caritas Czech Republic is responsible for the development of an e-learning tool related to storytelling methods.

Young Caritas in the Czech Republic

January 2020 – June 2023 | CZK 2,497,370 (Ministry of Education, Youth and Sport of the Czech Republic – OPRDE, ESF)

Young Caritas forms the basis for working with children and youths in the area of informal education with emphasis on values education, a participatory approach and positive motivation of young people in the area of social and societal responsibility and active citizenship. We organise summer and autumn day camps and SWAP clothing exchanges for them. Our employees are actively trained and introduce new informal education methods into their work in cooperation with other experts on the given issue. Our partners in this endeavour are the České Budějovice Diocesan Caritas, Hradec Králové Diocesan Catholic Caritas, and the Plzeň Diocesan Caritas.

YOUNG caritas FORUM 2023

How to get young people involved in the activities of Caritas Czech Republic?

We looked for answers to this question during the first Young Caritas Forum, which took place on the 25th of May 2023 at Kampus Hybernská. The day-long event was attended by dozens of colleagues, staff working with children and youth, volunteer coordinators, volunteers themselves and education methodologists. The feedback to the forum was so positive that we have decided to repeat it again in 2024. The YC Forum was made possible thanks to the support of Open Society Fund and the Ministry of Education, Youth and Sports of the Czech Republic.



FINANCIAL SECTION

COMMENTS ON THE FINANCIAL RESULTS FOR 2023

The year 2023 was a great challenge for Caritas Czech Republic, especially when it came to the continuation of services and assistance provided to citizens of Ukrainian nationality affected by the war both in the Czech Republic, and in Ukraine in cooperation with Caritas Ukraine.

The total financial result after tax for 2023 is loss of CZK 1,257,000.

The financial result is influenced by exchange-rate losses connected with the implementation of foreign projects.

The total volume of costs for 2023 amounts to CZK 345,813,000.

Caritas Czech Republic structures its spendings on its activities according to the individual areas, on which the departments of humanitarian aid and development cooperation, advocacy activities, education and awareness focus. These activities are supported by the communications and fund-raising departments, while administrative and management activities are handled by the economic and administrative department and the secretariat.

In 2023, the volume of costs for the Caritas Czech Republic's activities abroad amounted to 76% and for its activities in the Czech Republic to 18%. Its activities in the Czech Republic are mainly focused on support, cooperation and implementation of projects in the extensive Caritas' network represented

by 2 archdioceses (Prague and Olomouc) and 6 dioceses (Brno, Hradec Králové, Ostrava-Opava, České Budějovice, Plzeň and Litoměřice).

The economic activity is handled by the hotel and training centre Marianeum which offers accommodation, conference and catering services in the beautiful surroundings of Praque Vinohrady.


The total volume of revenue for 2023 amounted to CZK 344,556,000.

Caritas Czech Republic monitors the portfolio of sources of funding for its activities in four basic groups - donations, fund raising, which is separately monitored in terms of contributions from individual or corporate donors to public collections and within donor projects. The third group is economic activity, which is involved in financing projects both in the Czech Republic and abroad and, last but not least, in the development of the organisation and investments in economic activity. Other sources represent sources resulting from non-economic activities carried out by Caritas Czech Republic within its core business.



I. General accounting principles

The organisation keeps accounts according to Act No. 593/1991 Coll. on Accounting, as amended, and Implementing Decree No. 504/2002 Coll., as amended (hereinafter referred to as "Accounting Regulations"). The values in this appendix are given in thousands of CZK (TCZK), unless otherwise stated.

I.1. Fixed assets

Tangible and intangible fixed assets are assets with a useful life of more than one year and a valuation amount of TCZK 80 or more.

Buildings, land and works of art are considered tangible fixed assets, regardless of their cost and useful life.
Financial fixed assets are assets with a maturity of more than one year, regardless of valuation.

Fixed assets are valued at cost, i.e., including incidental acquisition costs, or at replacement cost (assets acquired free of charge).

Depreciation of tangible and intangible fixed assets is regulated by the depreciation plan and the company applies the straight-line method of depreciation.

Non-current small tangible assets with a useful life of more than one year, valued at TCZK 5 - 80, are charged to costs and recorded in the operational records. Exceptions are laptops and computers, which are recorded from a value of TCZK 0.

I.2. Securities and shares

The organization records purchased securities as part of short-term financial assets, see section "II.2. Shares, participation certificates, bonds, stocks".

I.3. Inventories

The organization values inventories at cost including incidental acquisition costs. Donated inventories are valued according to the donation agreement.

I.4. Receivables

Receivables are valued at their nominal value when incurred. In accordance with the decree, an organization may create allowances for receivables in connection with activities which are subject to income tax. Any allowances are then made in accordance with Act No. 593/1992 Coll., on provisions for income tax purposes. The organisation accounts for estimated accounts receivable in the case of written promises of subsidies for activities that have already taken place (reflected in costs) but will not be financially received until a later period.

The organisation accounts for the item "B.II.17. Other receivables" in accordance with the right to funds from foreign donors according to the accounting methodology specified in section I.8.3 Received subsidies.

I.5. Cash and securities

Cash and securities are valued at their nominal values. Separate bank accounts are set up for received funds from collections and selected tied donations (grants), on which these funds are registered and reported.

I.6. Foreign currency transactions

During the accounting period, the organization converts receivables and payables denominated in foreign currencies into Czech currency at the fixed monthly exchange rate announced by the CNB on the first day of each calendar month. Foreign exchange differences recognised at the end of the balance sheet date are presented, depending on their substance, in the profit and loss statement under "A.V.19 Exchange rate losses" or under "B.IV.8 Exchange rate gains". At the end of accounting period the value of funds, liabilities, receivables, subsidies and grants denominated in foreign currencies are converted into Czech currency at the CNB exchange rate as at 31 December.

Paid or received advances denominated in foreign currencies that have not been settled by the end of the financial year and are not expected to be repaid are recognised under "B.IV.1 Deferred expenses" and "B.IV.2. Deferred revenues" in accordance with the National Accounting Council's Interpretation I-43 and I-47.

I.7. Accrual

The organisation accounts for deferred expenses. Through deferred costs, it accrues costs that are related to subsequent periods.

Deferred income is used mainly for the accrual of subsidies from the state budget, which is described in more details in section 1.8.3 Received subsidies.

I.8. Funds and equity

In accordance with accounting regulations, the funds are accounted for as follows:

- public collections, which were announced in accordance with Act No. 117/2001 Coll.,
- and resources received by the company from other persons and companies for the purpose of fulfilling the main mission of the company free of charge: subsidies, donations, tied donations (grants).

In the equity accounts, the company accounts for assets acquired from subsidies, grants, donated assets and materials. The balance also includes economic results up to 2003.

I.8.1 Public collection

Within the statement position Own resources in item "A.I.2. Funds", the organisation captures (an analytical distinction according to individual collections within the 911 accounts) resources obtained from public collections. On an ongoing basis, the organisation accounts for the use of the proceeds by double entry to the debit of the public collection fund to the credit of the item in the profit and loss statement "B.IV.9. Settlement of funds" in the case of material consideration for any service provided. In the case of the disposal of a public collection as a financial consideration to another party, the debit to the fund is recorded in the balance sheet against the debit of monetary funds. The reported balance of the public collection fund corresponds to the unused amount from the public collection intended for further use, i.e., the balance of the collection bank account as at the balance sheet date. Any differences between the balance of the collection bank account and the reported balance of the public collection fund are explained in point II. Additional data to the statements.

I.8.2 Donation received

Received individual donations are accounted for by the organisation on the date of receipt to the credit of the item "A.I.2. Funds" and to the debit of asset items "B.III.1. Cash in hand" or "B.III.3. Cash at bank". The organisation accounts for the use of donations from the fund by double-entry to the debit of the fund and to the benefit of an item in the income statement "B.IV.9. Fund settlement" (financial, non-financial). The reported balance of the individual donation fund corresponds to the amount of unused donations.

I.8.3 Received subsidies

Received subsidies are funds provided from public sources, i.e., mainly from the state budget, from the budgets of local governments, from the sources of state budgets of foreign states and other foreign providers. The organisation accounts for funds from public sources within the Czech Republic when taking a decision in the asset item "B.II.12. Grants receivable and other payments from the state budget" and in the profit and loss statement "B.I.1. Operational grants". In the case of a multi-annual subsidy, the amount corresponding to the unused subsidy in the given year is deferred by the liability account in item "B.IV.2. Deferred revenues". In the event of the grant funds are not exhausted, a liability is reported under liability item "B.III.12. Payables to state budget" in the amount of its unused part.

Funds from public sources from abroad are recorded by the organisation at the moment of their receipt to the credit of item "A.I.2. Funds" and to income under item "B.IV.9. Settlement of funds" are charged at the time the costs are incurred. If the costs incurred are higher than the money in the fund, the organisation accounts for a receivable from a foreign donor under item "B.II.17. Other receivables" up to the amount of the subsidy according to the decision on the given subsidy and its non-financed part.

1.8.4 Fixed assets acquired free of charge

In equity under "A.I.1. Equity", the organisation records the sources of the acquisition of fixed assets acquired free of charge intended for use for the main activities. This value is dissolved at the same time as the depreciation of these assets and is shown in the profit and loss statement in item "B.IV.9. Settlement of funds".

I.9. Income tax

The organisation is a public benefit taxpayer in accordance with Section 17a of Act No. 586/1992 Coll., on Income Taxes, as later amended (hereinafter referred to as the ITA). The organisation applies the exemption of gifts pursuant to Section 19b paragraph 2 b) of the ITA whenever possible.


